**Memorandum of Understanding**

This Memorandum of Understanding (Herein after referred to as MoU) is being executed on this day i.e 8<sup>th</sup> day of October, 2021 by and between

**Savitribai Phule Pune University's Department of Education & Extension** having office at Savitribai Phule Pune University, Pune 411007. (Hereinafter referred to as SPPU's -Department of Education).

AND

**Dhruv Educational and Research Foundation**, Block no. 7, 'Shriniwas', 22/2 Mangalwar Peth, Parage Chowk, Pune 411011, Maharashtra, India. (Hereinafter referred to as DHRUV)



"SPPU's - Department of Education & Extension" and "DHRUV" are collectively referred to herein as the "Parties" and individually referred as "Party"

### **Preamble**

1. Department of Education & Extension is a part of SPPU created by Maharashtra Public Universities Act 2016.
2. WHEREAS Dhruv Educational and Research foundation is a Trust registered under Section 8 of the companies act 1956 and whose primary function is to provide Inclusive Education to specially-abled students.
3. "SPPU's - Department of Education and Extension" is engaged in providing courses in Education in the area of special Learning on Teacher Education.

**Now the MoU witnesses and the Parties hereby confirm and acknowledge that**

### **Binding Effect**

This MoU is not a contract. This MoU is only intended to set out the broad terms of understanding on a preliminary basis between the Parties. This MoU does not create binding obligations between the Parties. However, for the purpose of effectuating this MoU and to give legal and binding effect the Parties may enter into and execute the detailed contracts detailing the responsibilities, rights, obligations, representations, warranties, undertakings consideration/fees/compensation, etc.

### **SPPU Support**

SPPU's Department of Education & extension shall

- Shall decide eligibility criteria for the admission to the said programme.
- Shall prepare the syllabus of the said programme in consultation with "DHRUV" and get the same approved by its appropriate authorities .
- Shall guide "DHRUV" to undertake all the academic activities including conduct of examination leading to award of the degree under the said programme.
- Will cause inspection of campus of "DHRUV" through an officer of the SPPU so designated for the purpose by the Vice-Chancellor of SPPU to ensure that neither quality of the said programme is being compromised nor any norm/rule/regulation, for the time being in force, is being violated.
- Shall appoint examiners.
- Shall conduct final examinations, evaluate answer book, declare results and issue certificates to successful candidates.

### **DHRUV Support**

- Process the admission to the said programme which include issuing of advertisement for admission to the said programme after seeking approval of the Registrar of SPPU through the joint Programme Committee.
- Shall be responsible for conducting theoretical & practical classes as per curriculum and also be responsible for counselling of students.

- Shall collect fees from students admitted to the said program
- Shall bear all expenses incurred on conducting the said programme and SPPU shall bear no cost for the same.

### **Execution of detailed contracts**

In order to effectuate the broad terms stipulated in this MoU, the Parties agree to negotiate in good faith and execute such legally binding detailed contracts as may be necessary.

### **Sharing of Fees**

Fees chargeable for the course shall be decided by DHRUV and SPPU. Fees collected under this course shall be shared by DHRUV and SPPU in the ratio of 70:30. That means Rs. 70 to DHRUV and Rs. 30 to SPPU for every Rs. 100 of fees collected.

### **Eligibility**

School Teachers, Special Educators, Psychologists, Counselors, B.Ed/ D.Ed students, Parents of differently abled children shall be eligible to get admission to this course.

### **Mode of the course**

Combination of Online and offline will be used to run this course.

### **JOINT PROGRAMMEE COMMITTEE (JPC):**

Activities carried out under this MoU will be monitored by the JPC. The JPC will submit its report about the implementation of the MoU yearly, to the Vice Chancellor of the SPPU and to the President of the Dhruv.

The tenure of the JPC will be for a period of 3 years.

The JPC will consists of –

- a) Chairman of the JPC nominated by the Vice Chancellor of the SPPU.
- b) Two members nominated by the Vice Chancellor of the SPPU
- c) Two members nominated by the Dhruv.

Change in any of the modalities covered under this MoU will be decided by the JPC and the same will be binding upon the parties.

### **Intellectual Property Rights**

Ownership of the course content will always be with Dhruv Edu. & Research Foundation, which should not be reproduced /copied, without written permission of Dhruv Edu. & Research Foundation and it will have exclusive rights to use the contents for any other institute/University etc., anytime, even simultaneously during the period of this MoU period.

### **Third Party Rights**

This MoU does not confer any rights or benefits on any third party.

### **Effective Date**

The effective date of this MoU is the date it has been signed by all the Parties to the MoU.

### **Validity and Extension**

This MoU will be effective from the Effective Date and shall expired after a period of three years unless extended in writing with mutual consent of the Parties. Either Party may terminate this MoU without cause upon thirty (30) days prior written notice to the other Party.

### **Amendment of MoU**

This MoU may be amended provided that any such amendments are agreed to in writing by the




## Representations, Warranties and Authority

The Parties warrant that this MoU is validly formed according to the laws of India, and that they have full authority to enter into this MoU.


They also warrant that all the required essential sanctions to enter into this MoU were obtained.
