

## RULES FOR RESEARCH STIPEND

Rules for awarding research stipend for M.Phil. and Ph.D. students in various subjects under different faculties shall be as follows :

1. Students doing full-time research for M.Phil./Ph.D. and who are not employed anywhere shall be considered eligible for applying for the research stipend. However, the research stipend shall be awarded as per the rules given below. Mere fulfillment of minimum eligibility, therefore, shall not entitle the applicant to receive the research stipend.
2. The applications received shall be subjectwise classified and in each subject, two M.Phil./Ph.D. students (one for Open category and one for the Reserved category) in order of merit shall be selected for the award of stipend.
3. The Research Stipend shall be awarded to University of Pune students doing research only.
4. The stipend will be given to the M.Phil./Ph.D. students during the **first year** of registration only.
5. The stipend receivers will be required to report at the place of research regularly. A quarterly report of which shall be submitted by the student duly endorsed by the Head place of Research, along with the progress report. The progress report shall be duly endorsed by the research guide who shall specifically mention his remarks about the attendance and progress made in the work assigned during each quarter. Both the reports should be submitted to the Post-Graduate Section of University of Pune.
6. The cases of the candidates who are physically challenged as well as medical ground and any other special cases shall be referred to the Vice-Chancellor for final decision.
7. Students belonging to the reserved category shall submit validated caste certificate along with the application. The Reservation rules to be followed shall be as per Government of Maharashtra.
8. All the students shall submit an undertaking duly endorsed by the research guide that he/she is neither employed nor will accept any employment during the period of award for stipend.
9. The awardee will have to refund the whole amount received by him/her in case he/she discontinues studies prior to the completion of the period of award or violates any of the set rules.
10. A student availing of any kind of scholarship shall not be eligible. The applicant will have to execute an undertaking to this effect. If a candidate is found to be violating this condition, he/she shall be considered ineligible for any kind of financial support from the University including the 'earn and learn scheme'.
11. International students and students who receive any scholarship or award from other funding agencies shall not be considered eligible for this award.

The last date for submission of applications shall be 31st of August every year and the University Authorities shall communicate their decisions by 30th of September.
